As the judge's decision in the Stud Dog, Brood Bitch and Brace classes will be based on the merits of more than one dog or bitch, none of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed by virtue of having won these classes.

Stud Dog - Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. The Stud Dog may be entered separately in one of the Regular or Non-Regular Classes or if it is a Champion of Record, for Best of Breed Competition or may be entered for Stud dog Class only at the regular entry fee. The Get MUST be entered in one of the Regular Classes and MUST be indicated as "GET" in the additional class box on the entry form. The Stud Dog unit shall be considered as one entry and requires only one entry fee. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with his Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy or standard for the Breed.

Brood Bitch - Same as Stud Dog Class except substitute Brood Bitch for Stud Dog and Produce for Get.

Brace Class – Both dogs in each Brace, regardless of sex, must have at least one common owner. Will require a fee of \$20.00 for the Brace as a Unit if entered as an additional class. The dogs comprising a Brace MUST be named at the time of entry. If a dog which is to be part of a brace is not entered in another class it must be entered "For Brace Only", fee is \$25.00. In making entries for "Brace Class Only" full particulars must be given for each dog on individual regular entry forms. An entry form for a dog entered in another class and entered as part of a Brace MUST be marked accordingly in the space provided for Additional Classes "Brace Class." If more than one brace is entered by the same owner, the dogs comprising EACH Brace must be so designated "Brace No. 1" "Brace No. 2" etc.

ALL Sweepstakes classes are \$20.00 each. Dogs entered in the Sweepstakes must be entered in a regular class.

MAKE ALL CHECKS OR MONEY ORDERS PAYABLE TO GREAT PYRENEES CLUB OF METROPOLITAN MILWAUKEE. USE OF CREDIT CARDS FOR PAYMENT OF ENTRY FEES IS NOT ACCEPTED.

Entry fees include \$4.50 per entry AKC Event Service fee and the recording fee of \$0.50 for the first entry of each dog.



SPECIAL ATTRACTION - PEE WEE CLASS

The Pee Wee Special Attraction is a pre-Junior Showmanship class geared toward children 5-9 years of age. Children younger than five cannot participate in the Pee Wee Class Special Attraction as a safety concern.

Each Pee Wee unit consists of the child, his/her parent/guardian/responsible adult, and the dog. Only one Pee Wee unit is allowed in the ring at a time. This is not a competitive class, but rather a fun, learning experience for the child and the adult.

Entry in the Pee Wee class is limited to Great Pyrenees dogs at least four months of age. Bitches in season will not be allowed to participate. If pre-entered, a dog may be substituted that meets the eligibility requirements. All dogs must have the proper leash and collar. A responsible adult must be present with the child both inside and outside the ring. The adult is to maintain control of the dog outside the ring.

There is no fee to enter. The dog does not need to be AKC registered.

Pre-Registration is recommended, but walk-in entries will be accepted. All participants must provide a Release of Liability Waiver signed by the parent or responsible adult.

The PEE WEE Event will be held during the break between the morning and afternoon Specialties when there is optimal opportunity for spectators to watch and encourage the young handlers.
